## REQUIREMENTS OF PAPER EXECUTION

1. The thesis should be written in **Ukrainian, Russian, Polish** or **English**.
2. The volume of materials – 2-4 pages, not numbered.
3. Format – A4, text processor – MS Word; margins: top, bottom, right, left 20 mm.
4. Font – Times New Roman, size – 14, line spacing – 1,5, paragraph – 1 cm.
5. The structure of the thesis: in the upper right corner - **surname and name** of the author (in bold), scientific degree, academic rank, position, the name of the institution, city, country.
6. **Students and postgraduates in individual paper must specify a scientific adviser** as in the annex model.
7. Below - in one paragraph - **THESIS TITLE** (capital bold letters, centered).
8. Below - in one paragraph - the text of thesis (justified).
9. At the end of the text - in one paragraph - **References** (in bold and centered). References is made **according to the interstate standard DSTU 8302:2015** "Information and documentation. Bibliographic link. General requirements and rules of drafting". Links to references are presented in square brackets in accordance with the order of mention.
10. The use of illustrative materials, formulas in the report should be minimal.
11. The format of the tables and figures **should only be bookish**.
12. The Organizing Committee reserves the right of selection and editing of scientific papers.
13. Papers that do not meet the requirements, will not be considered.
14. Responsibility for the papers contents and execution shall be the author's and scientific adviser's.
