The Organizing Committee reserves the right to reject materials that do not meet the requirements for registration, topic of the conference or arrived late.

The authors will be informed about the inclusion of their reports in the program of the conference within three working days from the moment of receiving the materials by the organizing committee of the conference.

In order to compensate for the costs associated with the preparation and publishing of the abstracts, it is necessary to transfer the organization fee to the indicated bank account. The bank details will be sent to the conference participant as soon as they are informed about the acceptance of the submitted materials.

**The registration fee for participation in the conference is 150 UAH for participants who do not attend the conference (it covers receiving an electronic version of the Collection of the conference materials and an electronic certificate of participation), whereas it reaches 250 UAH for participants who attend the event (a participant receives one copy of the Collection of the conference materials and the printed certificate of participation).**

The registration fee covers the cost of publishing abstracts and organizational expenses for the conference. One copy of the Collection of the conference materials is sent to the address indicated by a participant (in case you need another copy, you will have to pay 80 UAH additionally).

**SUBMITTED ABSTRACTS SHOULD MEET THE FOLLOWING REQUIREMENTS**

1. The structure of an abstract:
  - UDC
  - the information about the author is placed on the right: in boldface, italics: last name, initials; in italics: the name of the university, position, degree, academic rank;
  - the title (in bold type);
  - the main text of an abstract.
2. Times New Roman, font size is 14, style is normal ;
  - line spacing is 1;
  - a first-line indent is 0.5 (do not use the tab key);
  - page parameters: margins are 2 cm top, left, right, bottom ;
  - citations are given in the text in square brackets ([2, p.17] where 2 means an item on the reference list, p. 17 is a page);
  - references follow the abstract and must conform to the current norms; the length of an abstract is 2-3 pages; pages are not numbered;
  - do not use any footnotes;

The author bears personal responsibility for the reliability of the presented facts and authenticity of the submitted abstract.

We also provide you with an opportunity to submit your articles to the Scientific Herald of Uzhhorod National University. Series "Economics". Issue 1 (51). Deadlines for submission: March 15, 2018.
