PUBLICATION OF CONFERENCE MATERIALS

According to the results of the conference will be published:

- collection of conference materials;
- collective monograph "Problems and prospects of financial provision of the agrarian sector: domestic and foreign experience". Topics of sections of the monograph within conference sections.

Abstracts of the participants will be published in the conference abstracts collection, which will be published before the conference. The Organizing Committee reserves right to select and edit manuscripts of scientific works.

REQUIREMENTS FOR SUBMISSION AND EXECUTION OF ABSTRACTS

To participate in the conference, **by August 1, 2018**, it is necessary to send (in electronic version) to the organizing committee an application for participation (sample is attached), abstracts and copy of receipt for payment of the organizational fee, recommendation-review, telephone number of scientific supervisor (for students).

To the publication will be accepted scientific works that have never been published.

The materials may be presented in Ukrainian (for citizens of Ukraine) and in English (for citizens of other countries).

In the subject line you must specify section number and name of the first author (for example, Section 2_Ivanov I. I.); title of the file should indicate section number and the author's last name (for example, 2_Ivanov_abstract, 2_Ivanov_application, 2_Ivanov_receipt).

The abstracts size should be up to 3 pages. Materials must be prepared using MS Word editor. Sheet format A4. Fields - 2 cm from all sides. Font Times New Roman, kegel - 14, interval -1,5.

PAYMENT FOR PARTICIPATION IN THE CONFERENCE

150 UAH - for remote participation (certificate of participant, publication of conference materials in abstracts collection and postal expenses for the delivery of the author's copy to specified address by ordered letter).

400 UAH - for full participation (organizational expenses, certificate of the participant, publication of conference materials in abstracts collection).

20 € (euro) - for participants from other countries - for abstracts up to three pages of A4 format (additional fee for each subsequent page will be 5 €). The sum consists of: abstracts in collection of

conference materials and postal expenses for delivery of author's copy to specified address by ordered letter.

The cost of an additional copy of abstracts collection is 50 UAH.

Attention! One copy of the abstract is sent to one publication, regardless of the number of authors. Additional collections must be ordered at the registration of the application (the cost of an additional copy of the monograph is specified by contact phone).

Accommodation and travel fees are paid by participants on their own.

REQUIREMENTS FOR EXECUTION OF THE MONOGRAPHY

Monography will be published by Austrian publishing house Premier Publishing s.r.o., Vienna.

The amount of material is 10-20 pages.

The work is done in the editor MS Word-6,0 (version is not older than Word-2003). The text should be saved with the extension * .doc, font Times New Roman, size 10, line spacing - 1, paragraph indent - 1 cm., page layout - A5, fields: upper, lower, left, right - 20 mm.

The text must be executed in accordance with the requirements and appropriate stylistic editing.

Formulas, tables (Times New Roman, size 8, line spacing - 1), figures are executed using special editors of MS Office, must be signed and sequentially numbered in Arabic numerals and executed in black and white (color graphics, graphs are not allowed). References to literary sources are made in form of footnotes at the end of the page.

Received materials are subjected to mandatory review. In case of positive review, invoice is sent to author to pay for the publication of the materials.

The publication cost is 550 UAH. for 10 pages of text (full or not full). Pages of abovementioned amount paid at the rate of 55 UAH. for each page.

Publication costs include: review, layout, print of the monography at Premier Publishing s.r.o. and delivery of author's copy (until December 31, 2018). Cost of additional copy is 250 UAH.

For foreign authors, the cost of publication is 25 euros, postage costs for delivery of copy to author (in accordance with rates set by Ukrposhta) are paid additionally!
