## **INSTRUCTIONS FOR AUTHORS**

Each submission must be accompanied by a cover letter written in English where the Authors must show the reasons for submitting their manuscript to *Folia Horticulturae*. In particular, 1) scientific importance, 2) novelty, and 3) relevance to horticulture must be addressed.

**Manuscript** must be saved in both formats PDF and Word 2007 or earlier versions. Continuous numbering of lines is required in both Word and PDF formats. Times New Roman 11 pt font should be used throughout the manuscript text. Bold face should be used for section headings. Use 1.5 line spacing and all margins of A4 page set to 2.5 cm. Genus and species Latin names should be typed in italics. Cultivar names should be included between inverted commas. Use S.I. system and standard abbreviations of units and symbols.

**Manuscript layout** should follow the below listed description. The Authors are also advised to refer to articles published in the last printed issue or online at www.versita.com/Folia Hort;

Running title; Title; Author's names: Name and address of the authors' affiliations; Name of the corresponding author, e-mail, tel. and fax numbers to the corresponding author;

**ABSTRACT** with 200-250 words providing information on the aim of the work, material and methods used, main results and conclusions:

**KEY WORDS** up to seven words listed alphabetically, they should not repeat words included in the manuscript title;

ABBREVIATIONS if any used in the manuscript, but not those generally recognized;

INTRODUCTION; MATERIAL AND METHODS; RESULTS DISCUSSION (or RESULTS AND DISCUSSION); CONCLUSIONS; ACKNOWLEDGEMENT

**REFERENCES** of an international coverage listed alphabetically. References to articles published in language other than English should be avoided. Use the Times New Roman 10 pt font; authors' names should be typed using a capitalized font face. Journal names should be abbreviated according to standards implemented in Medline database;

**TABLES** must be created using a word processor and included after the manuscript text, each table on a separate page. Each table must be self explainable and readable. Do not use vertical lines. Use a Times New Roman 9 pt font and single spaced lines in all table cells. Height of a single line row should be fixed to 5 mm using table/row properties. Text in the cells should be centred horizontally. Only text in the first column should be left justified. The table title should be written using a Times New Roman 10 pt font. A single page table size including the table title and footnotes is max. 166 x 247 mm; tables must be in a portrait orientation. Tables fitting to a one text column must be max. 79.5 mm in width;

**FIGURES** can be created by graphical packages but they must be embedded in the manuscript file at the end of the manuscript; each figure on a separate page. Each figure must be self explainable and readable. The figure size must fit to printing area of max. 166 x 247 mm including the figure caption and legend. Figures fitting to a one text column must be max. 79.5 mm in width;

**Colour figures** can be submitted and they will appear in colour in articles published online. They can be also published in colour in print, but only on the Author's request stated in the cover letter. See the cost section for charges applied to printing in colour.
