# REQUIREMENTS FOR THE THESIS:

- the total size of the thesis should be 2-3 A4 pages in Microsoft Word Editor, file format − \*.doc;
- font: Times New Roman, 14 pt, style «Normal», line spacing 1.5, paragraph indentation 12.5 mm; full justification;
- page margins 20 mm;
- formulas, figures and tables should be computer designed in black and white palette. Scanned materials are not allowed. Use of color and background is not allowed. All figures and tables should be entitled. Titles of tables and figures should be typed in font Times New Roman, 14 pt, bold. All figures should be grouped as a single object. Formulas should be centered and their numbering should be right-justified;
- hyphenation is not allowed in the text;
- pages should not be numbered;
- list of references should be placed after the thesis in alphabetical order;
- references to sources in the text should be given in square brackets.

Thesis will not be reviewed. Authors of publications are responsible for the authenticity of facts, quotations, proper names and other information.
