- The volume of papers 2 full pages, format A4 (297x210 mm), orientation portrait. Margins: up, down, left, right 20 mm. Font: typeface Times New Roman, size 14, line spacing 1,0; style Normal (normal).
- At the left corner of the page UDC.
- At the right corner of the page author (s) surname and name (full, bold), his/her status (DS, PhD, postgraduate student), position, department, institution.
- At the centre of the line title of the abstract in capital boldface letters.
- Indentation 1 cm. Pages of the abstract should not be numbered; do not use division of word.
- References should be placed (Times New Roman, 12 italic) at the end of the abstract; references on literature sources should be given in square brackets. Do not use hyperlinks.

WARNING! Participant has a right to provide abstract, which has not been published before. Please, follow thematic sections of the conference and requirements as to the abstract execution. The papers should be sent by the due date.
