The journal «Ukrainian Journal of Forest and Wood Science» is included in the List of scientific professional publications of Ukraine approved by the Ministry of Education and Science of Ukraine, in which the results of the dissertation works for obtaining the scientific degrees of doctor and candidate of sciences (approved by the order of the Ministry of Education and Science of Ukraine from 28.12.2019 № 1643) from the specialties: 187 "Woodworking and furniture technologies", 205 "Forestry", 206 "Landscape gardening".

The journal «Ukrainian Journal of Forest and Wood Science» is included in international scientometric databases: Index Copernicus, RINC, Google Scholar, Ulrichsweb, MIAR, BASE, EBSCO, AGRIS.

Languages of the edition: Ukrainian and English.

EDITORIAL POLICIES FOR PUBLICATIONS

- Original scientific articles of problem-solving and methodological nature are accepted in the scientific journal, in which the results of scientific researches with statistical data of theoretical and practical importance, have not been published.

- Authors are responsible for the originality (plagiarism) of the text of the scientific article, the accuracy of the facts, citations, statistics, proper names, geographical names and other information, as well as for the fact that the materials do not contain data that is not open for publication.

- The authors consent to the collection and processing of personal data for the purpose of their inclusion in the database in accordance with the Law of Ukraine No. 2297-VI “On Protection of Personal Data” of 01.06.2010. The editorial board of the journal guarantees that personal data, except for those that are public submitted in the article will be used solely for internal editorial purposes and will not be distributed or transmitted to outsiders.

- Authors who have a Ph.D. (Ph.D.) degree need to be instructed by their supervisor.

PROCEDURE FOR SUBMITTING THE SCIENTIFIC ARTICLE

1. To the edition of the scientific journal through the system **OJS** (<http://journals.nubip.edu.ua/index.php/sanu/index>) an electronic document package is sent (see Annexes):

- information about the authors (Vidomosti_Ivanenko.doc);

- scientific article (Paper_Ivanenko.doc);

- extended abstract of the article in English (if the text of the article is Ukrainian) up to 1800 characters (Abstract_Ivanenko.doc);

- review, signed by a doctor of science (from an external institution) and certified by the seal of the institution where the reviewer works.

2. After reviewing the scientific article by the editorial board and subject to a positive decision on its publication, the authors will be sent a corresponding email to the email with the attached receipt.

3. The Editorial Board reserves the right to further review, edit and reject scientific articles.

4. The editorial board does not consider the materials, designed without observance of the requirements for the submission and design of scientific articles.

REQUIREMENTS FOR THE DESIGN OF SCIENTIFIC ARTICLE

1. Scientific articles with a volume of 15 pages of text, paper size – A4, orientation – book, margins on all sides – 20 mm, line spacing – 1,5, font size – 14, headset – Times New Roman, paragraph – 1 are accepted for consideration cm (for the body of the abstract and article only).

2. The structure of the scientific article:

– **LAB** (left-aligned, bold). You can determine the LAB code at this link: <http://teacode.com/online/udc/>;

– **Name of the article** (in Ukrainian/English, center alignment, boldface, capital letters);

– **Author's initials and surnames** (in Ukrainian/English, center alignment, boldface); **degree, position, title of department or place of work**;

– **ORCID** each of the authors of the article;

– **The official name of the organization, city, state** (in Ukrainian/ English, center alignment, italics);

– **E-mail:** _____ .

Annotation. Abstract volume 220–250 words. Must be concise, without unnecessary words, to reflect the main content of the article, as well as structured and written in good English (font size – 14, italic, line spacing – 1). Composite abstract can be constructed on the principle of IMRAD (Introduction, Methods, Results and Discussion): 1–2 sentences about the relevance of a problematic research question; a brief description of research methods; main results (specific facts); specific conclusions and prospects for further research (1 sentence). The content of the annotation should be clear without becoming familiar with the body of the article. You must use an active, not passive collateral ("The study tested", not "It was tested in this study").

Key words: 4–6 words (phrases) that reflect the content of the article (font size – 14, italics, line spacing – 1)

– **Article title** (in Ukrainian/English, center alignment, bold, capital letters);

– **Author's initials and surnames** (center alignment, boldface);

– **The official name of the organization, city, state** (in Ukrainian/English, center alignment, italics).

The requirements for the abstract in English are similar to the Ukrainian version.

In each of them, you work in the prepared Ukrainian language, make sure that it is indicated on the drive, placed at the desired stage, and several times give its English version. Using English, you can increase the number of abstracts - the opposite.

Requirements for the main sections of the article:

Introduction – in which the urgency of the scientific problem is presented and the facts known in the world literature are presented, with an indication of the unresolved issues. It is desirable to analyze the scientific facts of the last 5 years. References to literary sources in the text of a scientific article should be given in parentheses by: (Last name, year), for example: one author – (Putchkov, 2013), two authors – (Peter & Prince, 2018), three or more authors – (Lonappan et al., 2016; Lu et al., 2017; Sarkar et al., 2017). In conclusion, the main task of the scientific research is formulated in the form of the purpose or hypothesis of the article.

Material and research methods – describes in detail the scheme of the study, the conditions and place of the experiment, the main methods and methods of research (with reference to the source), reagents and devices (the company, model and country of origin). This section should contain as much information as possible to further reproduce the results published. Finally, information on statistical data processing methods is provided.

Results of the study and their discussion – the results of the study and their analysis are given with a comparison with known facts (preferably in the last 5 years). The requirements for this section are general, as is the case for all international scientific publications.

Tables and figures by volume should not exceed 30% of the text. The pictures should be editable. You should not cite the table or figure as a separate sentence.

Conclusions and Prospects – specific results of the analysis (preferably with a full text of up to 10 sentences) and prospects for further research should be provided.

Gratitude (if necessary!) are submitted after the conclusions before the bibliographic references.

At the end of the scientific paper, **References**, a list of sources used, (no more than 20 sources) in alphabetical order (font size – 14, line spacing – 1), without numbering, in English, which is formed according to the international standard APA (**for placing manuscripts in international ones**) This standard is used in the United States to draw up articles (including a bibliographic list), adopted by the APA (American Psychological Association), and is **INTERNATIONAL**. To facilitate the design of sources to this standard, we recommend using the link <http://www.slovnyk.ua/services/translit.php>. The transliteration of Ukrainian symbols should be carried out **in accordance with the CMU Resolution No. 55 of January 27, 2010, and** the Russian ones according to the BGN / PCGN system. The following are examples of designing different types of sources according to the proposed standards (Annex 2).

Tabular and graphic material can only be in book format, and its quantity is appropriate. The table must have a serial number, indicated on the left in front of the table name. The name of the table is given above the table (font size – 14, bold, line spacing – 1.5, width). The text of the table is given by the Times New Roman font (font size 12, line spacing 1).

The drawing should be a single graphic object and grouped; have a number and a name that is indicated outside the object (font size – 14, bold, line spacing – 1, width). The location of the figure should be in the text. Drawings should be in contrast, black and white or color. Graphics should not be scanned.

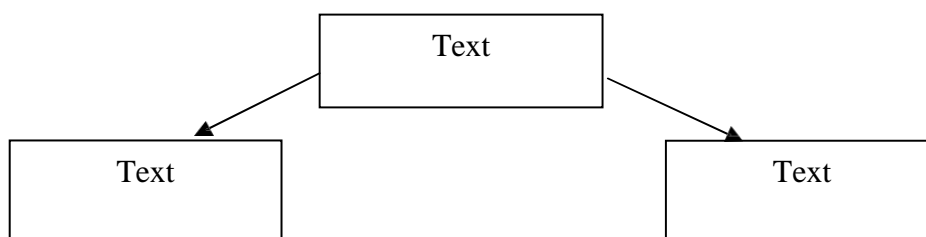


Figure 1. Name of image
