## HISTORY OF THE FACULTY OF ECONOMICS

**The training of agricultural specialists in economics was initiated in 1898** with the establishment of the Department of Agriculture in Kyiv Polytechnic Institute, our University is originated from. Twenty academic courses were taught at the Department of Agriculture, including political economy, agricultural economy and statistics forming the economic training of future specialists. Separate Department (Division) of Economics did not exist at the Department of Agriculture, and the teaching of economic disciplines has been coordinated by Professor A.K. Lyudohowsky – one of the founders of the science of the agricultural system in our country.

In the 1905-1917, economic disciplines were taught on the Department of Agricultural Economics and Statistics, headed by the Master in Agriculture, Professor Bazhaiev V. G. For the period of 1921-1929, Professor Veselovskyi S. F. was elected as a head of the Department and approved by Ukrainian Scientific Committee. In 1929, Kyiv Agricultural Institute together with the Department was moved from the territory of KPI to Holosiievo.

In July-August 1941, Kyiv Agricultural Institute was evacuated to Alma-Ata. Departments of the Institute joined in the relevant departments of the Kazakh Agricultural Institute and continued to train specialists for the rural economy, and on returning to Kyiv in 1944, despite the war, the institute has resumed training.

By the Order of the Minister of Higher Education of the USSR №768 from 05.15.1951 the Faculty of Economics and Organization of Agriculture was established in the Kyiv Agricultural Institute.

Professor Grygorovych D. A. was its first Dean until 1960. The Faculty had the only Department of Economics. After becoming the part of the Ukrainian Agricultural Academy in 1954, the Faculty of Economics and Organization of Agriculture started training specialists in accounting at the Department of Accounting (1959), economists-mathematicians at the Division of Cybernetics (1966-1995), in 1994, the Department of Finance and Credit was initiated. In 1995, the Faculty of Agricultural Management was established based on the Faculty of Economics. Its academic staff was filled up primarily by the graduated of the National Agricultural University.

At different times, the position of the Dean of the Faculty was held by Professors Larin G. C. (1960-1965), Novakov I. P. (1965-1969), Olefir K. I. (1969-1976), Kireytssev G. G. (1976-1983), Tarasenko G. S. (1984-1997) Tereschenko V. K. (1997-2001), Kvasha S. M. (2001-2008), Ibatulin S. I. (2008-2011), Kaminska T. G. (2011-2014). In 2015, Professor Dibrova A. D. became the Dean of the Faculty.

Among the teaching staff there are: Academicians of the NAAS of Ukraine Kvasha S. M., Tereschenko V. K.; Corresponding Member of the NAAS of Ukraine Ilchuk M. M., Zhuk V. M.; Professors Dibrova A. D., Yermakov O. Y., Zbarsky V. K., Zelisko I. M., Kalyuga E. V., Savchuk V. K., Solodkyi M. O., Suk L. K., Suk L. P., Khudoliy L. M., Rogach S. M., Vdovenko N. M., Davydenko N. M., Legeza N. M. and others.

There are many reasons for the Faculty of Economics to be proud of. Over the years, there were trained: 24513 specialists in economics in ED "Bachelor", "Specialist" and "Master", including economists – 9101, accountants – 10397, financiers - 3377, economists-mathematicians – 847 (by 2000), specialists in taxation - 251; 45 Doctors of Economic Sciences and 560 Candidates of Economic Sciences.

Among the former graduates of the Faculty, there are prominent politicians, deputies of the Verkhovna Rada of Ukraine (of different convocation), members of the Ministries and government agencies, heads of famous enterprises in agricultural sector. The most famous are Bozhok T. I., Zhuk V. M., Zaiets I. O., Kireytsev G. G., Lissitsa A., Plusch I. S., Sabluk P. T., Sakhnevych V. S., Pavlovsky M. O., Shvydenko M. M., Gagaluk T. V., Bedziura I. P., Osadchuk V. I., Vlasiuk O. S., Perekhozhuk O., Komirenko Z. The Faculty is proud of its numerous graduates, who implement the knowledge obtained in their alma mater, in all the areas of economy for the benefit of the country. They can be a model for other students of the Faculty.

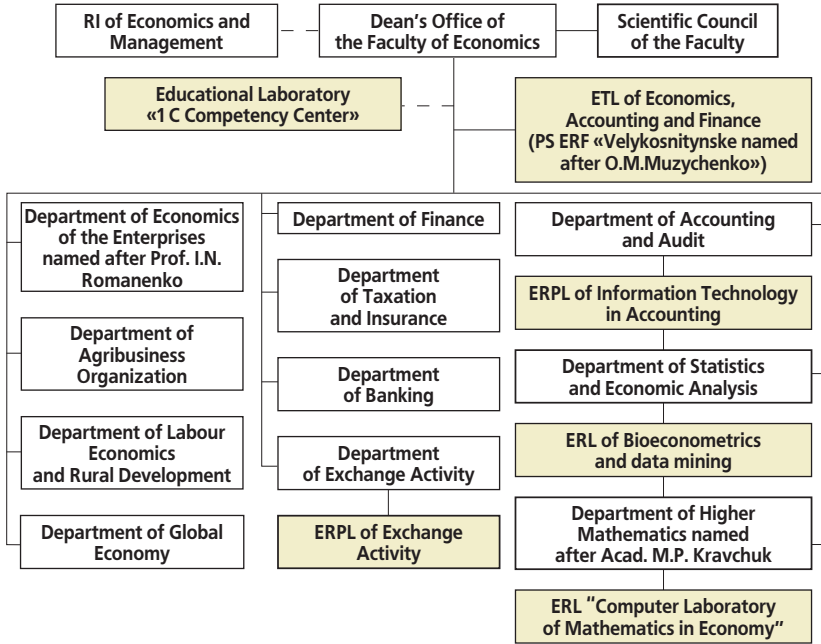

### **Research Institute of Economics and Management of Agricultural Production was established in 2001, based on the Faculty of Economics.**

In 2001-2005 it was headed by Doctor of Economic Sciences, Professor. M.M. Ilchuk, in 2005-2011 – by Doctor of Economic Sciences, Professor, Academician of NAAS of Ukraine, Honored Scientist of Ukraine, O.M. Shpychak. In 2011, the Director of the Research Institute became Doctor of Economic Sciences, Professor Mykola P. Talavyria. In December 25, 2014, the Research Institute of Economics and Management of Agricultural Production was renamed to the Research Institute of Economics and Management.

The aim of the Institute is to develop basic and applied research in economics and management of agricultural enterprises and participation in international projects, grants and conferences.

As of May 1, 2016, there are 81 graduate students, including: 55 full-time and 26 part-time. During the last 5 years, 12 Doctors of Sciences and 80 Candidates of Sciences have defended their theses in the University Specialized Councils.

Training of high qualification scientists is carried out in specialities: 08.00.03 - Economics and Management of the National Economy, 08.00.04 - Economics and Management of Enterprises (by types of economic activity), 08.00.06 - Economics of Natural Resources and Environment Management, 08.00.07 - Demography, Labor Economics, Social Economics and Politics, 08.00.08 - Money, Finance and Credit, 08.00.09 – Accounting, Analysis and Auditing (by types economic activities).

There are 2 Specialized Scientific Councils for the theses defense in economic specialties: D. 26.004.01 and K. 26.004.17 and Scientific Council for the preliminary defense of the Research Institute of Economics and Management.

Since 2016, the Faculty trains Doctors of Philosophy – PhD in specialties: 051 "Economics"; 071 - "Accounting and Taxation"; 072 - "Finance, Banking and Insurance"; 076 - "Business, Trade and Exchange Activities".

Research work of professors, postgraduate and doctoral students is focused on the solving out priority economic problems of the agricultural sector of Ukraine: Development of agrarian policy of Ukraine under the European integration (Prof.

Kvasha S.M., Prof. Dibrova A.D., Assoc. Prof. Zhemoyda O.V.); Forecasting of bioeconomic capacity of agriculture in Ukraine under the risks of climate change (Prof. Dibrova A.D., Assoc. Prof. Riabchenko O.O.); Improving the competitiveness of the agricultural sector under the formation and functioning FTA with the EU (Prof. Kvasha S.M., Prof. Vdovenko N.M.); Development of proposals to improve the quality and competitiveness of animal production (cattle and poultry) in Ukraine (Prof. Ilchuk M.M.); Development of financial and economic mechanism of agriculture efficient functioning under the new taxation (Prof. Khudoliy L.M.); Development of rural areas (Prof. Tereshchenko V.K.); Improvement the organizational and economic mechanism of management in agricultural production (Prof. Yermakov O.Y.); Areas of formation and functioning of the EU Common Fisheries Policy and the ways of its implementation in Ukraine" (Prof. Vdovenko N. M.).

Students of the Faculty are being actively involved in research activities.

In their research, the Departments work closely with the Institute of Agricultural Economics of the NAAS of Ukraine, Institute for Economic Forecasting of NAS of Ukraine, Department of Agricultural Economics and Food of NAAS of Ukraine and relevant departments of other agricultural universities. The RI supports and develops international relations of the Faculty in science and education with universities in the USA, Canada, Germany, France, the Netherlands, Belgium, Italy, Poland, Slovak Republic, Czech Republic, Hungary, South Africa, Greece, Bulgaria, Belarus, Georgia, Kazakhstan, Latvia, Japan.

The first Head of the Department was a member of the Lenin All-Union Academy of Agricultural Sciences, Doctor of Economics, Professor Romanenko I. N. (1954-1975). At present, the Head of the Department is Rohach S. M., Doctor of Economic Sciences, Professor (since 2015).

**Main task of the Department** is to train highly qualified specialists in the field of economy to meet the needs of sustainable development of Ukrainian society and create an advantageous educational environment aimed at training professionals and creative individuals who have fundamental theoretical knowledge with practical experience.

The Department trains “Bachelors” and “Masters” in specialty “Economics”. The Department developed and implemented Master’s program “Economy of Agricultural Sector”.

**The goals of the Department are:**

- to form the new generation of Ukrainian economists, who can create and implement an enterprise development strategy on the basis of efficiency and competitiveness in the context of global economic challenges;
- to provide fundamental and applied investigations aimed at deeper theoretical and methodological principles, prove practical recommendations concerning the efficiency of economic entities; improve the quality of educational process by implementing innovative methods and mode of study.

From 2012 to 2017 the Department has been carrying out scientific research on the subject “The competitiveness of organizational and legal forms of agricultural business under the condition of globalization”.

Scientific studies are administered on the problems of functioning efficiency of organizational and legal management forms; forming organizational and economical mechanism of competitive production; environmental and economic efficiency of reproduction of natural and resource potential in agriculture.

Due to the urgent necessity to solve the problems of social and economic development of the rural areas at the beginning of the 20th century, the Department was renamed into the Department of Agrarian Sociology and Development of Rural Areas. In 2013-2014 it has been integrated part of the joint Department of Economics of the Enterprise. Since April, 2014, the Department has received the title of the Department of Labor Economics and Development of the Rural Territories.

Since November 2015, the Head of the Department is Professor, Honored Economist of Ukraine, Oleksandr E. Yermakov. The area of his scientific activity is the organizational and economic principles of efficient management in agriculture.

**The main purpose of the Department** at the present stage is to prepare specialists of ED "Bachelor" within the specialty "Economics" and ED "Master" for Master's program "Labour Economics and Social Partnership" via formation of fundamental knowledge of the theory and practice of labor economics in agro-industrial sector of Ukraine and the professional competences in different functional areas of the economy that provide highly professional staff for the national economy.

The employees of the Department carry out in-depth research of the actual problems of labor and production improvement, the study of the mechanisms of law observation, scientific development of practical recommendations for their implementation.

Currently, 15 members of the academic staff work at the Department, including 2 Doctors of Economic Sciences, 9 Associate Professors, Candidates of Economic Sciences and 3 Assistants. Today, the Department is presented by experienced and ambitious young scientific and academic staff.

Apart from the training of Bachelor and Master students, the Department carries out thorough training of personnel of higher qualification through postgraduate and doctoral studies. Over the years of the department' functioning, more than 110 Candidate and 16 Doctoral theses have been defended. Professors O. Yermakov, V. Tereshchenko, O. Shkilov are the members of Specialized academic councils of Doctoral theses defense.

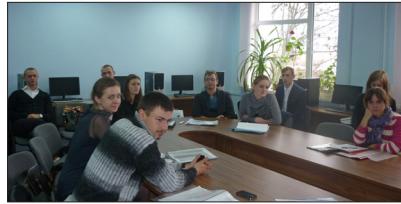

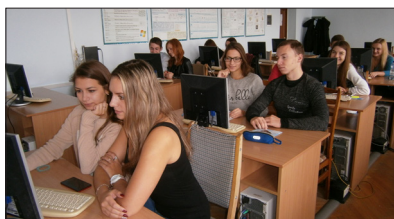
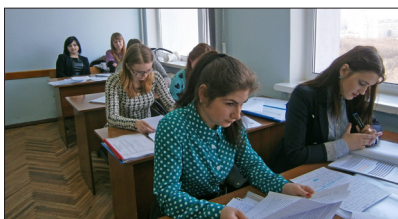
