## 2. Goals and objectives of the course

The course «Information systems and technologies in economics» is designed to provide the necessary knowledge about the theory and practice of using modern information systems and technologies in economics. The acquired skills of working on a personal computer with an operating system and major software packages such as MS Word, MS Power Point, MS Excel and online systems will enhance the performance of the tasks by future specialists.

The knowledge and practical experience gained during the course will significantly expand students' opportunities in mastering a set of special disciplines: statistics, mathematical modeling of economic systems, computer programming, databases in management systems, information systems in accounting, etc.

*As a result of studying this course, the student should know:*

- the basic concepts and terminology of the course, rules and algorithms of data processing by means of various software, general principles of construction of modern information technologies and systems;
- basic composition and organization of interaction of typical modern information technologies used in professional activity, modern tendencies and trends in the field of hardware and software of office activity;
- structure and purpose of modern information technology software;
- general concepts and principles of effective information retrieval;
- principles of work with the main services of the Internet and ways to use them in professional activities;
- general concepts and principles of effective information retrieval;
- the role of information technologies and information systems in the economic sphere, methods of using universal and specialized information technologies and systems;
- basic concepts of data storage, security and protection, information technologies and systems.

*Be able to:* build an information model of the subject area, use ICT for data processing and organization of teamwork for their creation and reuse; to analyze information related to a particular subject area using modern office computer programs; determine rational methods and ways of using application software to solve problems in the specialty; apply basic techniques of information and information-analytical work with the use of computer technology in professional activities.

**The course provides the formation of a number of general and special (professional, subject) competencies:**

### **3. The program of the course**

#### **Module 1. Theoretical basics of economic informatics**

##### **Topic 1. Theoretical basis of economic informatics.**

*Classification of economic information.* The concept of computer science, information and data. Information, its types and quantitative measurement. Data, their types and structure. Data carriers. The main directions of computer science development. The importance of computer technology in improving the efficiency of the accountant.

*The hardware structure of a modern computer.* Composition, purpose, interaction and characteristics of basic devices (processor, memory, external devices). Structural and functional scheme of the PC. Modern PC hardware market.

*The structure of modern computer software.* Composition, purpose, and main functions. System software. Tool software (programming systems). Application software. Modern PC software market.

*Working with PC software for the economic sphere.* Determining the necessary software for the future accountant. Distribution of programs by categories. Implementation of the description of programs in accordance with the functional purpose.

*Features of work in the Internet.* Search for information on the Internet. Search rules. Keywords. Selection of search results by relevance. Familiarity with online systems for finding economic and legal information.

*Network office.* Working with Google Apps. Familiarity with the principles of the network office. Overview of the types and features of Google Apps. Create and co-edit Google Docs and learn how to work with a shared calendar.

##### **Topic 2. Basics of working with business documentation.**

*Working with text documents in MS Word.* Creating a text document. Text document formats. Enter, save and download documents. Text formatting. Display unprinted characters. Character formatting: font setting; Formatting toolbar; insertion of non-standard and special symbols; initial letter. Paragraph formatting: creation of lists; insertion of mathematical formulas and symbols; converting text to a table.

*Working with non-text objects in MS Word.* Working with tables. Creating and deleting tables. Editing a table. Formatting tables. Calculations in the table. Creating formulas. Editing formulas. Placement of formulas in the text. Tables and charts in MS Word. Insert charts and graphs into a document. Editing charts. Types of diagrams. Insert pictures. Placing pictures in the text. Picture formatting. Drawing of graphic constructions by means of MS Word, work in the WordArt program. Import graphic objects. Creating an organizational chart. Editing an organizational chart.

*Working with the structure of a text document.* Document templates. Using styles and elements of auto text in text documents. Structuring the finished text by

sections and subsections. Formatting structured documents. Page numbering. Formation of automatic content.

### **Topic 3. Visualization of information and basics of working with computer graphics.**

*Basic rules of working with the presentation.* Basics of working with data presentation technology. Creation of illustrative material by means of desktop publishing systems and development of an animated video with the help of MS PowerPoint. Review and use online designers for presentations.

*Creating illustrative material for printing.* Overview of types of advertising illustrative materials and programs for their creation. Creating an illustrative booklet by means of desktop publishing systems, on the example of MS Publisher. Study of features of development of illustrative material to scientific information.

*Basic principles of working with raster graphics.* Techniques for creating and editing illustrative material by means of graphic editors (for example, Photoshop online). Possibilities and rules of work with layers (layers). Overview of image editing and color replacement tools.

### **Topic 4. Basic concepts and role of information systems in management.**

*Information systems:* characteristics, stages of development. Classification and structure of information systems. Automated ICs in financial and banking institutions. Principles of creation and functioning of IP in financial and credit institutions. Means of creating and providing automated information technologies at enterprises.

## **Module 2. Processing and analysis of economic information in MS Excel**

### **Topic 5. Presentation and visualization of economic information in MS Excel.**

*Data entry.* Introduction of formulas. Select of cells, ranges of cells, rows, or columns. Enter sequences of numbers, dates and text. Using AutoFill. Cell formatting: number formatting, alignment, border creation and background fill.

*Working with simple formulas.* Creating a formula. Mathematical operators. Absolute and relative addressing. Introduction to the formulas of dates and times. Errors in formulas. Replacing the formula with its calculated value. Using built-in functions. Linking of formulas.

*Data visualization.* Structural elements of diagrams. Creating and customizing charts. Construction of diagrams of different types. Stages of creating diagrams. Creating a basic (embedded) chart. Improving the base chart. Examples of visualization of economic processes using business graphics.

*Excel toolbars.* Moving to worksheet. Data entry. Introduction of formulas. Allocate cells, cell ranges, rows, or columns. Entering sequences of numbers,

dates and text. Using AutoFill. Format cells: number format, alignment, frame creation and background fill.

### **Topic 6. Using spreadsheet functions for data analysis.**

Familiarity with the ability to perform calculations using MS Excel functions for business analysis. IF function and its application. Functions AND, OR and NOT and their application. Calculating the values of logical functions with many conditions. Use of logical functions when their value is textual for certain conditions.

Problems on simple and complex interest. Calculations of financial functions. Functions COUNTIF and SUMIF and their application. Implementation of extensive computational processes in Microsoft Excel.

### **Topic 7. Organization of databases in MS Excel.**

Organization of the database. Create lists. Data entry. Search records. Arranging records. Using Auto Filter. Using AutoFormat. Advanced filter. Functions for working with databases.

Generation of consolidated tables. Data consolidation. Interim Results. Automate the execution of procedures in MS Excel by creating macros and applying a package of analysis for financial and scientific data.

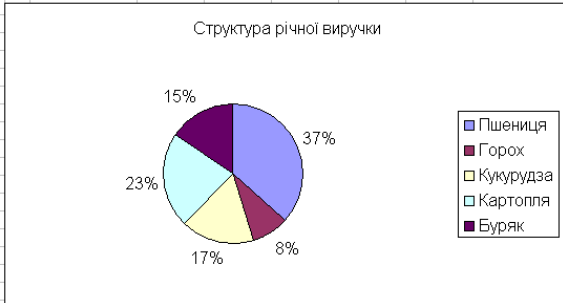
