

Letter of Intent

between

the Education and Research Institute of Energetics and Automatics,
National University of Life and Environmental Sciences of UKRAINE

and

the Faculty of Agronomy and Bioengineering,
Poznan University of Life Sciences (PULS) – POLAND

Basing on long-term agreement and cooperation between National University of Life and Environmental Sciences of UKRAINE and Poznan University of Life Sciences (Poland) covering science, education, research, innovation and practices, the Education and Research Institute of Energetics and Automatics, National University of Life and Environmental Sciences of Ukraine and the Faculty of Agronomy and Bioengineering, Poznan University of Life Sciences (PULS) – Poland have reached mutual understanding on the ways in which they intend to develop cooperation:

1. On the basis of mutual interest and availability of necessary resources, these two institutions agree to cooperate in the following areas:

- a) coordination of educational programs in preparing the energy profile;
- b) joint preparation of textbooks, manuals, presentations of educational materials;
- c) scientific cooperation in joint research and innovation projects for such priority areas as:
 - creation of hybrid energy systems for the agricultural sector and means of automation,
 - process automation and development of intelligent control systems;
- d) two-way participation in conferences, workshops, seminars in partner Universities;
- e) educational and cultural exchange of students and academic staff.

2. In the framework of bilateral agreements would be implemented the following general forms of cooperation:

- a) exchange of academic materials and information;
- b) exchange of teachers and researchers;
- c) exchange of students, graduate students and conduct professional training and the development of joint practical and educational programs for students (including two exchanged students from each University per each academic year);

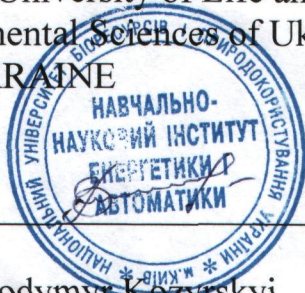
3. Themes for common cooperation, conditions of usage the results of common cooperation, and agreements touching upon visits, exchanges and other forms of cooperation will be developed together on each specific kind of activity.

4. Financial agreements will be discussed on each particular project and against availability of monetary funds.

5. The agreement covers the period of five years (since day, when the agreement was signed).

6. The agreement was signed in two copies (including one copy for each partner).
