4500 kg of excisable goods are imported to the customs territory of Ukraine. The customs value of imported goods is \$ 7,000. USA. At customs clearance is paid:

- customs duty for customs clearance of goods (USD 55);

- duty (rate - 18%);

- excise duty (rate - 30 euros per 1000 kg);

- VAT (rate -20%).

Exchange rates on the date of registration of the cargo customs declaration: for 1 euro - UAH 38.37. ; for 1 USA - UAH 36.17.

Calculate customs duties.

System of customs taxes and customs duties. The essence, classification and types of duties. Export, import and transit duties. Ad valorem, specific and ad valorem duty. Types and cases of use of special duty: antidumping, countervailing and seasonal. Autonomous, conventional and preferential duties. Constant and variable duty rates. Nominal and effective duty.

Customs value of goods. Methods of determining the customs value in Ukraine. Country of origin of goods. Calculation of customs payments.

#### Topic 7

The essence, basic principles and tools of currency regulation. Mechanism of currency regulation and currency control in Ukraine. Legal regime of currency relations. Powers of state bodies in the field of currency regulation and currency control. Administrative and economic instruments of currency regulation. Currency intervention, devaluation and revaluation, currency restrictions, establishing currency convertibility and diversification of foreign exchange reserves.

Monetary policy and control. Procedure for purchasing and using currency. Settlements in noncash and cash currency. Violation of currency legislation.

## Topic 9

#### Taxation of foreign economic activity of enterprises

Characteristics of the system of taxation of foreign economic activity in Ukraine. Principles of taxation of subjects of foreign economic activity in Ukraine. Analysis of the main legislative and regulatory acts governing the taxation of foreign economic activity in Ukraine.

Force majeure circumstances - definition, procedure of description and application. List of legislative and regulatory acts of Ukraine regulating the form, procedure for concluding and implementing foreign economic agreements (contracts).
