DESCRIPTION OF THE DISCIPLINE

The curriculum involves understanding that the animal reflects the conditions in which it lives. The well-being of an animal is ensured if it is healthy, in a comfortable and safe environment, receives a balanced diet, can behave naturally, does not suffer from unpleasant conditions such as pain, fear and stress. This approach covers all aspects of the animal's life, including appropriate indoor conditions, management, feeding, disease prevention and treatment, responsible humane treatment and, where appropriate, humane euthanasia.

Ethology studies the behavior of animals, especially in natural conditions. Students must gain a broad understanding of the fundamental principles and issues of animal welfare and behavior. Basic understanding of local, national, regional and international animal welfare legislation.

The study of professional ethics allows in the form of situational tasks, practical training to assess and improve oral and written communication skills of the student (eg: writing medical history, communicating with the client on treatment and diagnosis; critical reading and reflection on epidemiology, immunology, microbiology; public Understanding of the Code of Professional Conduct and Veterinary Ethics, local and national legislation and regulations governing veterinary activities.

Based on the acquired knowledge, the specialist will formulate and implement appropriate animal welfare policies at the local, national, regional and international levels through legislation, regulation and operational strategy.

As a result of studying the discipline the student must:

know:

- forms of individual, reproductive and social behavior of animals;
- features of physiological processes that are associated with behavior; legislation governing the proper treatment of animals; Professional traditions and ethics of a veterinarian.

be able to: use knowledge of ethology and zoopsychology of animals as a basis for solving the following possible ways of using and keeping animals;

- analyze the action and dependence of animals on adaptive and social behavioral responses;
- to assess the types of higher nervous activity of animals, to form their proper behavior;
 - assess animal welfare and take measures to improve it.
