Submission guidelines:

- 1. The participant may send only one abstract, which has not been published before, including co-authorship.
- 2. The maximum number of authors is three (including the supervisor). It is obligatory for students and graduate students to indicate in the thesis of the supervisor.

- 3. Abstract length is up to 3 pages, which are not numbered.
- 4. Abstract text: sesquialteral-spaced, Times New Roman, font 14, indention 1 cm, all margins 20 mm.
- 5. The use of illustrations in abstracts should be minimal. Table font 12; title font 14.
- 6. Only booksize format of tables and figures.
- 7. The author is responsible for content and design.

Sequence of abstract data placing:

- UDC on the left, Times New Roman, font 12.
- Author names (not more than three) (position, academic degree, academic status, full name)
- Full institutional affiliation;
- Abstract title (block letters, semibold);
- Abstract text;
- Recommended literature must be compliant with the requirements used for designing academic papers. References should be indicated in square brackets in the text by the ordinal number of this work according to the list of sources used.

Abstracts are published in the author's edition. The authors are responsible for the abstracts' scientific quality, validity of conclusions, veracity of results, and plagiarism.
