- analyze problematic situations of international agrarian relations at the current stage;

- make practical decisions on issues based on knowledge of modern international agrarian relations;
- to form one's own scientific position in the assessment of modern trends of international relations in the agrarian sphere.

### 7. The teaching method

The teaching method is an interconnected activity of the teacher and students, aimed at students' assimilation of the system of knowledge, acquisition of abilities and skills, their education and general development. In a narrow sense, the teaching method is a way of guiding the cognitive activity of students, which should perform three functions: teaching, educational and developing. A component of the training method is the reception of training. Reception of training is a set of specific training situations that contribute to the achievement of the intermediate (auxiliary) goal of a specific method. The richer the arsenal of techniques in the structure of the method, the more complete and effective it is.

Teaching methods are classified into: methods of ready-made knowledge (students passively perceive the information provided by the teacher, memorize it, and if necessary reproduce it) and research method (presupposes active independent work of students in acquiring knowledge: analyzing phenomena, formulating a problem, proposing and testing hypotheses, independent formulation of conclusions), which is most fully realized in the conditions of problem-based learning. When studying a discipline, students mainly use the method of ready-made knowledge in lectures, while in seminars - the research method. It is the latter that allows you to consolidate, generalize and systematize the acquired knowledge.

Depending on the origin of information, the following are distinguished: verbal, visual and practical methods; from the goal: methods of acquiring new knowledge, methods of forming skills and abilities, methods of applying knowledge in practice, methods of creative activity, methods of consolidating knowledge, abilities and skills, methods of testing and evaluating knowledge, abilities and skills. At lectures, we use presentations, because visualization of the material improves the level of perception. All other methods are also used.

### 8. Forms of control.

According to the place of control in the educational process, preliminary (incoming), current, milestone and final control are distinguished.

**Preliminary control** (diagnostics of students' initial level of knowledge) is used as a prerequisite for successful planning and management of the educational process. It makes it possible to determine the existing level of knowledge of the day of their use by the teacher as an orientation in the complexity of the material. Preliminary control in the form of verification and evaluation of residual knowledge is also carried out some time after the final exam in a certain discipline, both for the purpose of assessing the strength of knowledge and for the purpose of determining the level of knowledge of the supporting subjects to determine the possibility of accepting new educational disciplines.

**Current control** of knowledge is an organic part of the entire pedagogical process and serves as a means of detecting the degree of perception (assimilation) of educational material. Management of the educational process is possible only on the basis of current control data. The tasks of current control are reduced to:

- to reveal the volume, depth and quality of perception (assimilation) of the material being studied;
  - identify deficiencies in knowledge and outline ways to eliminate them;
- to reveal the degree of responsibility of students and their attitude to work, establishing the reasons that prevent their work;
- identify the level of mastery of independent work skills and outline the ways and means of their development;
  - stimulate students' interest in the subject and their activity in learning.

The main task of current control is to help students organize their work, learn independently, responsibly and systematically study all subjects. Current control is a continuation of the educational activities of the teacher and the teaching staff, it is related to all types of educational work and should teach students to prepare for the test from the first day of classes and every day, not at the end of the semester or academic year. At the same time, the current control is an indicator

of the work of the teaching staff. Of course, students study up to ten subjects simultaneously in a semester, and not all teachers make the same demands on them.

**Frontier (modular) control** of knowledge is an indicator of the quality of studying individual sections, topics and related cognitive, methodical, psychological and organizational qualities of students. Its task is to signal the state of the students' learning process in order to take pedagogical measures for its optimal regulation.

The final control is an examination of students with the aim of assessing their knowledge and skills in accordance with the specialist model. The final control includes semester, course and state exams, as well as tests before the exam. The main purpose of the exams is to establish the actual content of students' knowledge in terms of volume, quality and depth and the ability to apply them in practical activities.

# 9. Distribution of grades received by students

Evaluation of student knowledge is carried out on a 100-point scale and is converted to national grades according to Table 1 "Regulations and Examinations and Credits at NULES of Ukraine" (order of implementation dated 01.05.2023 p. № 404)
