## 2. Purpose, objectives, and competencies of the course

**Purpose:** train the highly qualified specialists on the basis of the processes of the humanization of school, integration of the professional and social-humanitarian base, improvement of the content and structure of the course, use of the achievements of the world and national ideas, common values.

**Objectives:** study of the history of Ukrainian statehood and the deep understanding of the history of formation of the Ukrainian people and Ukrainian state system, consolidation of the national originality, interpretation of the political activity of the classes and social group in Ukraine at the certain stages of the historical development.

### **Acquisition of competencies:**

### **3. Program and structure of the course for full time students**

#### **Course program**

Module I. Ukrainian State: Cuts, Forms, Trends.

Lecture 1. Introduction to the Course "History of Ukrainian Statehood". Subject, tasks, methodological principles and sources of studying the course "History of Ukrainian statehood". Scientific periodization of the history of statehood on Ukrainian lands. The first principles of statehood on the Ukrainian lands. Diversity of scientific concepts and hypotheses of ethnogenesis of Ukrainians and their state creation.

Lecture 2. Genesis of Ukrainian statehood in the Middle Ages: scientific polemics. Theories of origin and stages of formation of the state of Kyivska Rus'. Features of the political organization of Kyivska Rus'. Historical fate of Ukrainian statehood in European context.

Lecture 3. The latent period of the Ukrainian state, diversity and contradictory interpretations. Historical and political aspect of foreign expansion to Ukrainian lands. Ukrainian society in the processes of Lithuania and Poland's integration and creation of the Commonwealth of Both Nations. Evolution of the Ukrainian Cossacks. The phenomenon of the Zaporozhian Sich.

Lecture 4. Ukrainian national revolution (mid XVII century). Ukrainian National Revolution: Issues to be discussed. Pereyaslav Agreement of 1654, its assessment in historiography. Elimination of the old state system and the birth of the Ukrainian Cossack-Hetman state.

Lecture 5. The Cossack Hetmanate. Time of Ruins and loss of territorial integrity at the end of the seventeenth century. Liquidation the Ukrainian statehood in the XVIII century by the tsar: law or colonial policy.

Lecture 6. Revival of Ukrainian ideas National self-determination (the end of XVIII-XIX centuries). National-state opinion during the period of Ukraine's stay under the authority of the Russian and Austro-Hungarian empires. Modernization processes in the Ukrainian lands: administrative-political, socio-economic, cultural and educational spheres. The question of Ukrainian statehood in the socio-political movement.

Lecture 7. New trends in socio-political life of Ukraine at the beginning of XX century. Politicization of public life: the formation of political movements and parties. The arrangement of social and political forces on the verge of the national liberation struggle. Ukrainian movement in Austria-Hungary. State-building models in the program documents of Ukrainian political movements and parties.

Module 2. On the way to revival of state (XX-XXI cen.).

Lecture 1. Evolution Ukrainian state in 1917-1920. Historical circumstances of the revival of Ukrainian statehood. Search for the best models of state building. Ukrainian Revolution 1917 - 1920 pp.: achievements and mistakes in state-building competitions.

Lecture 2. The Soviet form of statehood (1921-1939). Historical conditions for the formation of the Soviet form of statehood in Ukraine (1917-1920). Soviet Ukraine in the system of "treaty federation". The controversial nature of political and economic development of the Dnieper Ukraine in the 20-30's of the twentieth century.

Lecture 3. Ukraine and the Second World War: A New Paradigm. The Ukrainian question in international relations on the verge and in the beginning of the Second World War. Contribution of the Ukrainian people to victory over Nazism. Historical and legal consequences of the Second World War for Ukrainian statehood.

Lecture 4. Changes in the political life of Ukraine (40-80 years of the twentieth century). Features of the post-war period: objective conditions and subjective factors. An attempt to liberalize the political regime (1953-1964). The growth of crisis phenomena in the political life of Ukraine in the 60's and 80's of the twentieth century.

Lecture 5. Historical features of state processes in independent Ukraine (since 1991). Independent Ukrainian state: ways of legitimization. Historical angle of the constitutional process and its role in political reform of Ukraine. Ukrainian vectors of international politics.

Lecture 6. Agro-industrial complex of Ukraine. Conceptual approaches to the agro-industrial complex reform. Agrarian reform in independent Ukraine. Social and socio-psychological aspects of the reform of the agro-industrial complex.

Lecture 7. Ukraine and the World: geopolitical factor in a historical retrospective. Sovereign Ukraine in the modern geopolitical space. Russian-Ukrainian war. Ukraine and the European integration process. Eastern and Western Ukrainian Diaspora in Interstate Relations.

Lecture 8. Prospects of Ukrainian state in the XXI century. The Concept of Sustainable Development and Strategic Prospects of Ukraine. Political system of Ukraine: ways of democratic transformations. Socio-economic factors of national development in the XXI century.

## **7. Teaching methods.**

The method of training - activities linked teacher and students, aimed at mastering system knowledge acquisition and skills, their education and overall development. In a narrow sense teaching method is a way of management cognitive activity students should perform three functions: teaching, educational and developmental. Multiple teaching method is receiving education. Receiving training - a set of specific learning situations that contribute to the intermediate (supporting) goals specific method. The richer arsenal of techniques in the structure of the method, so it is high-grade and efficient.

Teaching methods are classified into: the methods of ready knowledge (students passively accept the information submitted by the teacher, remember, and if necessary, recreate it) and research method (involves active independent work of students in mastering knowledge: analysis of phenomena, formulation problems and test hypotheses nomination, independent drawing conclusions) that most fully realized in terms of problem-based learning. In the study of discipline students in class method is used mainly ready knowledge while on seminar - research method. The latter allows you to consolidate, compile and systematize knowledge.

Depending on the origin of information release: verbal, visual and practical methods; purpose: methods of obtaining new knowledge, technique and skills formation, the method of application of knowledge in practice, creativity techniques, methods consolidate the knowledge, skills, methods of verification and assessment of knowledge and skills. At lectures we use presentations, as illustrate material improves perception. Also used by all other methods.

## **8. Forms of assessment**

For a place that takes control of the learning process, distinguish the previous (input) current, a modular control and final control.

**Previous monitoring** (diagnostics output level of student learning) is used as a prerequisite for the successful planning and management of educational process. It helps identify existing knowledge of the day to use them as a teacher orientation in the complexity of the material. Ante control in the form of test and evaluation of residual knowledge also spend some time after the final exam in certain subjects as to assess the strength of knowledge and to determine the level of knowledge on subjects providing opportunities to determine the perception of new disciplines.

**Current control** knowledge is an integral part of the whole educational process and serves as a means of identifying the degree of perception (learning) training material. Learning management is possible only on the basis of the current control. The task of this control are reduced to that:

- identify the scope, depth and quality perception (mastering) of the material being studied;
- identify shortcomings in knowledge and identify ways to address them;
- identify the degree of responsibility of students and their attitudes to work, finding the causes that hinder their work;
- identify the level of mastering the skills of independent work and identify ways and means of development;
- stimulate student interest in the subject and in the knowledge of their activity.

The main task of this control - to help students organize their work, learn independently, responsibly and systematically study all subjects. Current control - a continuation of the training of the teacher and the teaching staff, it is associated with all kinds of academic work and must teach students to prepare for the inspection of the first day of classes and every day, not the end of the semester or school year. However, the current control is a measure of the work and the teaching staff. Of course, semester students study simultaneously up to ten items, and not all teachers put them to the same requirements.

**Modular control** of knowledge is an indicator of quality study of selected chapters and topics related cognitive, methodological, psychological and organizational qualities of students. His task - to signal the status of teaching students to take educational measures for optimal regulation.

**The final control** is the exam students to assess their knowledge and skills in accordance with the model professional. By the final control includes semester, course and state exams and tests before the exam. The main purpose of examination - establishing actual content in terms of student learning, the quality and depth of skills and apply them in practice.

## 9. Distribution of grades received by students

Evaluation of student knowledge is carried out on a 100-point scale and is converted to national grades according to Table 1 "Regulations and Examinations and Credits at NULES of Ukraine" (order of implementation dated 01.05.2023 p. № 404)

In order to determine the rating of a student (listener) in the discipline  $R_{dis}$  (up to 100 points), the rating from the exam  $R_{ex}$  (up to 30 points) is added to the rating of a student's academic work  $R_{aw}$  (up to 70 points):  $R_{dis} = R_{aw} + R_{ex}$ .
