1. Online discussions and individual work on the topic (13th -19th January 2025)

"Digital Transformation in Education"

Duration: 30 HOURS / 1 ECTS CREDIT

2. Individual Research Work (20th -26th January 2025)

- Research topic include:
 - 1) Innovations in corporate finance and their implications for financial security.
 - 2) The future of international economics.
 - 3) Digital applications for financial security and transparency.
 - 4) The role of AI and big data in corporate finance and risk management for SMART university management.
 - 5) Sustainable Finance: Integrating Environmental, Social and Governance (ESG) Criteria into Corporate Finance Decisions for SMART University Governance in the Face of Digitalization and Extraordinary Challenges.
- Preparing reports and offering recommendations on how the financial sector can adopt digital technologies to enhance sustainability and security. Preparing presentations summarizing research findings, discussions with peers and experts.

Duration: 30 HOURS / 1 ECTS CREDIT

3. Roundtable Discussions (27th January – 2nd February, 2025)

- Topic: "Digital Technologies in Corporate Finance: Opportunities and Risks for Financial Security and Sustainable Development for SMART University Governance in the Face of Digitalization and Extraordinary Challenges".**

Duration: 30 HOURS / 1 ECTS CREDIT (preparation, participation, and discussions).

4. Individual Research Work (3rd -15th February, 2025)

Participation in online seminars and workshops focused on the practical application of digital technologies in finance, such as the use of blockchain for secure financial transactions, AI-driven financial modeling, and the role of digital finance in promoting sustainable development. Duration: 60 HOURS / 2 ECTS CREDITS (preparation, participation, and discussions).
