2. The aim and objectives of the course

The aim of the course "Foundations of private relationships" is to provide students with modern theoretical and practical knowledge about the importance of the regulations and institutions of the general part of civil law, legal regulation of civil relations in Ukraine, as well as the formation of certain abilities and skills in practical application of the current legislation to solve problems arising and accumulated in the process of resolving civil disputes.

The objective of the course “Foundations of private relationships” is to introduce the main provisions of civil law and its institutions; the scientific and theoretical heritage of civil law science; analysis and generalization of judicial practice in the sphere of private law; development of skills to independently solve scientific and practical problems of private relations.

Participation of government and local communities in civil legal relations and its legal forms. The grounds of origin, modification and termination of civil legal relations.
